Explanatory note:
 Each action type has costs raised against it. All action types have incurred summons costs and liability order costs. Of the 3,930 action types remaining, 2,045 have yet to clear their summons costs and similarly 2,151 have liability order costs outstanding.

This effectively means that the summons costs have been cleared in 1,885 cases, and liability order costs in 1,779 cases.

The council tax system allocates payments so that the costs are cleared first, in accordance with the regulations.
