**Killingdown Farm** - That land at Killingdown Farm to be allocated for between 140-180 dwellings phased post 2026 with a view to bringing it forward if needed or retaining it as undeveloped if appropriate to contribute to the next plan period and that the Green belt designation be removed from the site area (up to Little Green Lane) to form a defensible boundary.
