

THREE RIVERS DISTRICT COUNCIL (LAND AT HENBURY WAY, OXHEY DRIVE, BRIDLINGTON ROAD, ST ANDREWS ROAD, THE PARADE, PRESTWICK ROAD, FAIRFIELD AVENUE AND STATION APPROACH, SOUTH OXHEY) COMPULSORY PURCHASE ORDER 2016

THE TOWN AND COUNTRY PLANNING ACT 1990

AND THE ACQUISITION OF LAND ACT 1981

Three Rivers District Council (in this order called "the acquiring authority") makes the following order –

1. Subject to the provisions of this order, the acquiring authority is, under Section 226 (1)(a) of the Town and Country Planning Act 1990 hereby authorised to purchase compulsorily the land described in paragraph 2 for the purpose of facilitating the carrying out of development, redevelopment and/or improvement on or in relation to the order land including the demolition of existing buildings, for the provision of mixed use development including residential, and commercial uses comprising C3, A1, A3, D1 and D2 use with associated infrastructure, car parking and other community facilities thereby achieving the promotion and/or improvement of the economic, social and environmental wellbeing of the area.
2. (1) The land authorised to be purchased compulsorily under this Order is the land described in the Schedule below and delineated and shown coloured pink on 5 maps prepared in duplicate, sealed with the common seal of the acquiring authority and marked:
 - (i) "Map referred to in Three Rivers District Council (Land at Henbury Way, Oxhey Drive, Bridlington Road, St Andrews Road, The Parade, Prestwick Road, Fairfield Avenue and Station Approach, South Oxhey) Compulsory Purchase Order 2016 Location Map".
