#### Statement of Representations Procedure for commenting on the 'Issues & Options and Call for Sites Consultation Document' under the Town and Country Planning (Local Planning) (England) Regulations 2012 (Regulation 18)

Three Rivers District Council is preparing a new Local Plan that will guide and manage future development in the District up to 2032. The Council has published for consultation the 'Issues & Options and Call for Sites Consultation Document' that outlines the issues and potential options for the management of development within Three Rivers District up to 2032.

The Council is inviting comments on the 'Issues & Options and Call for Sites Consultation Document' for a six week period starting on Friday 28 July 2017 until Friday 8 September 2017. The Council is also undertaking a call for sites during the same period of consultation.
