Guidance Notes

2. The address of the person or organisation should be the address given in Part 2 of their application for a provisional statement.

If the premises have no address, then the ordinance survey map reference and description given in Part 3 of the provisional statement application should be inserted here.

4. If the provisional statement is in respect of a vessel, the place where the vessel is situated or moored for the purposes of the provisional statement should be entered here.
