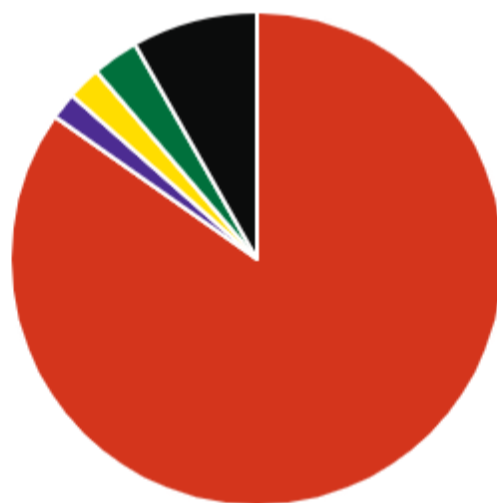

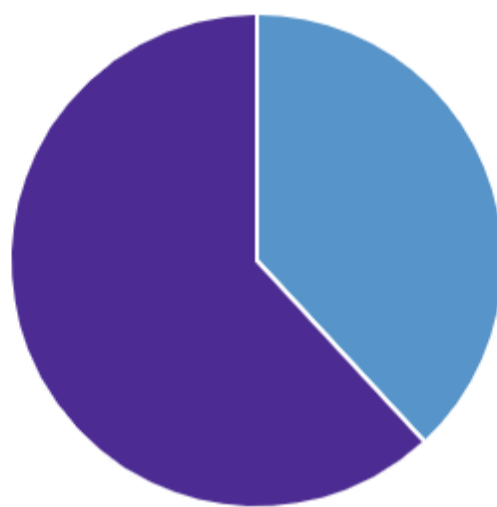

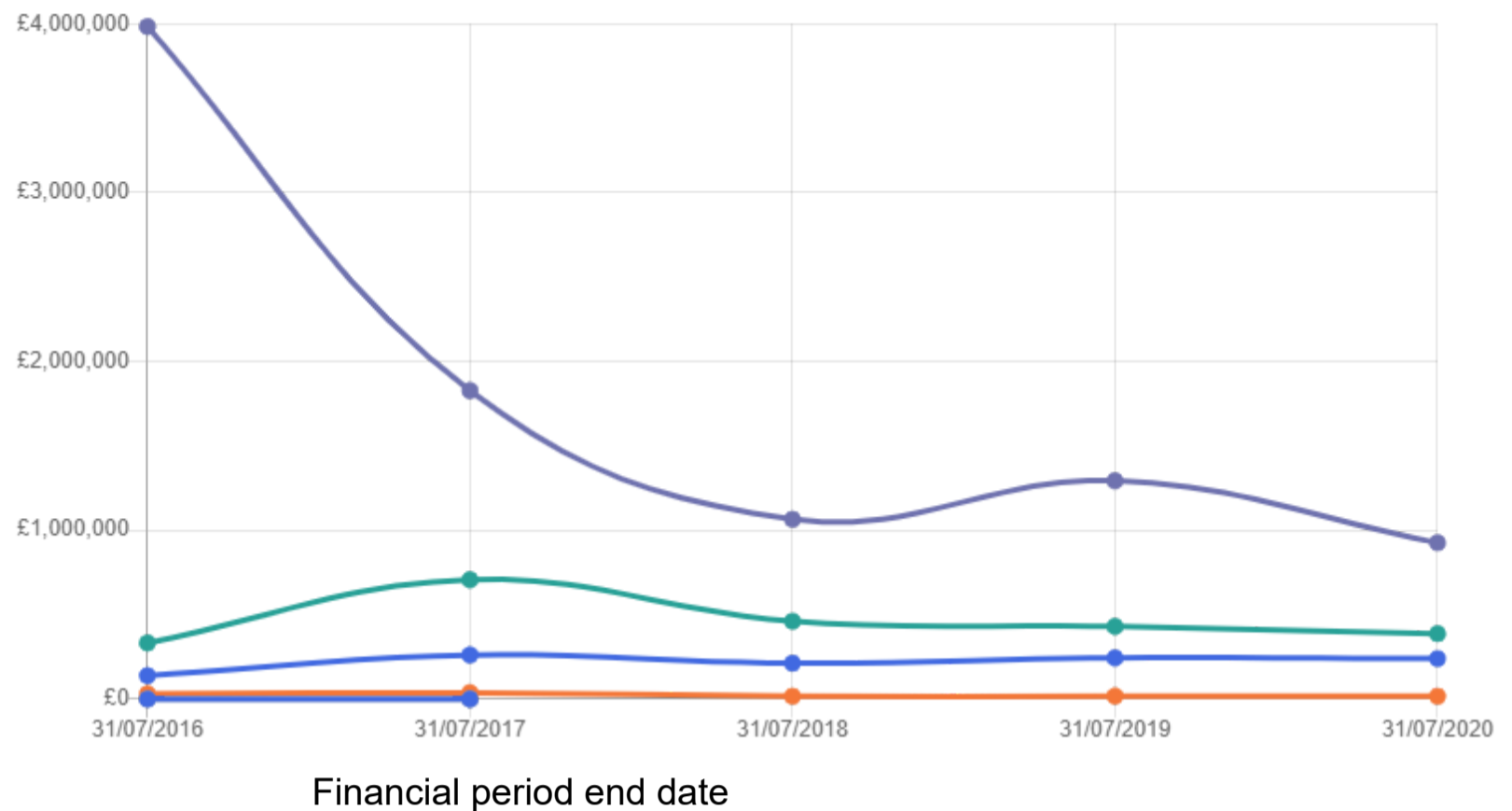
# Trustees
